## Membership Dues Schedule

A sliding scale is used to assess dues from the following: global North-based private foundations, public foundations, faith-based giving programs, and governmental giving programs. Gw/oB recognizes that many grantmaking institutions make both “domestic” and “international” grants. Grants made strictly for domestic purposes need not be included in the dues assessment. Dues are assessed only on “international” grants, including:

- ❖ Cross-border grants (i.e., grants made to organizations outside the home country)
- ❖ Grants made in the home country with global intent, for example to an international relief organization or for global policy concerns
